## **Members Named to Constitution Reform Commission**

Montgomery -- Governor Bob Riley convened the organizational meeting this morning of his newly created Alabama Citizens' Constitution Commission in Montgomery.

Commission members from across the state gathered in the Joint Briefing Room of the Alabama State House to listen to the governor's direction, plan their course of action, and organize into committees. Each panel will study, debate and draft suggested amendments to the state constitution regarding limited home rule to county governments, the excessive earmarking of tax dollars, increased line-item veto power, a higher-vote threshold for tax increases and a recompilation of the state's lengthy and unorganized governing document.

Along with choosing former Secretary of State Jim Bennett to chair the committee and Birmingham lawyer Lenora Pate as its vice-chair, Gov. Riley appointed the following citizens to the commission:
